1. Introduction

2. Collecting personal information

2.1 Fintech Asia Pacific (Pvt) Ltd may collect, store and use the following kinds of personal information:

3. Using your personal information

(e) to any person who Fintech Asia Pacific (Pvt) Ltd reasonably believes may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information.
